While she was pretty fascinated by the culture and the opportunities there, her classmates shocked her with their comments and ideas about the country and its locals. She will address how important it is to realize culture is a fluid, a spectrum and not a disc or a box.

"A Crossroad between Aspiration and Duty"

United States of America Ratna Raja (Indonesia)

Originally from Indonesia, Ratna has lived her life in multiple nations including India, Australia and the United States. Today she will be talking about the political changes in Indonesia and the United States that have revealed and shaped her identity status and kept her in the journey of identifying and effectively dealing with life-changing challenges.

"Ojos Nuevos: Seeing the New Challenges of Global Medicine in Peru"

Matthew Mayeda is an osteopathic medical student that studied abroad in Iquitos, Peru during the summer semester of 2018. One of the things he now loves the most is (American) football; his passion for the game has a significant impact on his life, and ultimately his career path.

Mitchell is a graduate student in Computational Mathematics Science and Engineering (CMSE) and also works with Campus Edge Fellowship, a graduate/professional student ministry at MSU.

Desiree traveled to San Ignacio, Belize with the College of Social Science for a service learning expedition. For a week, she learned about and encountered contemporary issues within a developing country. She will share with you her experience of listening to young kids open up to her about their mental health and how her week-long trip made a lasting impression.

In his presentation, he will discuss the challenges and obstacles he faced over the course of his journey relating to identity, cultural shocks, and adaptations, as well as the lessons he picked up along the way.

"The Greece They Don't Show You"

The presenter had the opportunity to study abroad in Greece for 6 weeks. Not only did he gain knowledge he also gained a new outlook on life. Working with refugees opened Zach's eyes and helped him to appreciate the little things in life. Throughout his presentation he will discuss his experiences working with refugees and how he has grown through the study abroad.
